Editorial Preface

International Journal of Doctoral Studies (Vol. 3)

This volume represents the third year for IJDS and the journal continues to grow. In this volume, IJDS continues to provide an outlet for quality peer-reviewed scholarly articles on a wide variety of issues related to doctoral studies. Although the journal received considerable increase in the number of articles submitted for review from previous years, the IJDS editorial board has accepted only the few that are both relevant to the journal readership and are of the quality approved by the editorial board.

This third IJDS volume includes six manuscripts. Buckingham' article. Development of English Academic Writing Competence by Turkish Scholars, presents a qualitative study based on 13 Turkish researchers and their struggles with English writing skills. Specifically, her study discusses the difficulties non-native speakers of English have in writing academic research articles in English for publications in quality journals. Buckingham concludes with proposed strategies that may help school administrators address the struggles of these researchers. Dondlinger and Jones's article, Situating Educational Computing Doctoral Students in a Community of Practice: A Rubric-driven, Online Portfolio System, outlines a rubric-driven online portfolio system for doctoral students. Their article uses situated cognition theory as the theoretical foundation for the design and development of such online portfolio system. Dondlinger and Jones conclude with some benefits that such a system provides for students and faculty members in doctoral programs. Stahl et al.'s article, The Social Side of Theory: A Community-Based Narrative of Research and *Theory*, discusses the role of theory in research from the perspective of novice researchers. They outline seminars that increase awareness of such role for doctoral students in order to develop a research community. Wong's article, Explication of Tacit Knowledge in Higher Education Institutional Research through the Criteria of Professional Practice Action Research Approach: A Focus Group Case Study at an Australian University, presents research based on a doctoral candidates' focus group related to the adoption and use of the knowledge management processes. Wong also discusses the reflective practice research approach, a type of action research, and concludes with some tips on developing such unique research skills. Knight and Steinbach's article, Selecting an Appropriate Publication Outlet: A Comprehensive Model of Journal Selection Criteria for Researchers in a Broad Range of Academic Disciplines, proposes a model for researchers on deciding to which journal they should submit their research manuscript. Knight and Steinbach proposed their model based on five key considerations in the journal selection process. They conclude with some hands-on tips for researchers to better select a targeted journal for their research manuscript, which ultimately can reduce researchers' frustration and increase likelihood of the manuscripts' acceptance. The final article in this volume is a book review by Wise, Book Review: Doctorates Downunder: Keys to Successful Doctoral Study in Australia and New Zealand. In this review, she outlines the key aim of the book and its contribution to students' success in their doctoral program. Wise discusses some of the key chapters from the book and concludes with her views related to the issues discussed in the book.

I would like to thank the IJDS advisory board member, Prof. Marc Schniederjans, C.
